Tennis Court Resurface and Possible Pickleball Court

Joe Armstrong presented four different options to resurface the tennis court at the small pool, ranging from \$14,000 – over \$100,000. A motion was made by Joe Armstrong and seconded by Tyler Urruty to approve Joe to move forward with the Economy Plus option and obtain firm quotes for a final decision to be made. The motion carried unanimously.

Joe also presented preliminary information on cost of converting the east side of the sports court at the big pool to pickleball courts. The Board authorized Joe to obtain additional information and quotes before a decision is finalized.

Sidewalk Repair, Tree and Stump Removal and Tot Lot Access Path

The Board discussed a cost share proposal for the removal of tree roots that have damaged the Association owned sidewalk to the Tot Lot. It was advised that roots will need to be removed. Mike McCurdy made a motion to defer any decisions until finalized pricing can be obtained. Pam seconded the motion and the motion carried unanimously.

2018 Electrical Improvements

John Van Royen and Allan Meers provided an update on the work that needed to be done to complete the electrical work at the pools. The cost will be between \$20,000 and \$30,000. A motion was made by Matt Brozovich and seconded by Jim Gilmer to move forward with obtaining formal bids to have the electrical work completed. The motion carried unanimously.

Tyler Urruty presented the financial statements for the period ending October 31, 2017. First Hyland Greens has assets totaling \$138,632.43 in the operating accounts and \$600,614.08 in the reserve accounts.

Pam provided an update on her research for the trash contract for the 2018-2019 service year.

Greenbelts
