Updates on Hyland Greens Properties

The Hyland Greens HOA Board and Management company receive many questions regarding two properties in the neighborhood and what is being done. While we cannot legally share with you the specific actions being taken by the Management company we would like to provide some updates.

For both properties, the board has been in contact with the City of Westminster to further understand what is being done by code enforcement in each case.

10121 Yates Ct


This property suffered a fire in the summer of 2018. Over the last year and a half, very little work has been done other than initial fire damage mitigation. The Colorado Department of Public Health and Environment (CDPHE) ordered interior and exterior asbestos abatement as part of the restoration efforts. This abatement work is currently under litigation with the contractor who completed the work after the CDPHE marked the work as incomplete. Westminster Code Enforcement is now in contact with the city prosecutor's office regarding next steps for enforcement to continue to

move this property forward in its restoration.

4688 Hyland Greens Pl.

This property was a troubled property for a number of years. In early 2019, the property was sold. The new property owner is in the process of renovating. Westminster Code Enforcement has issued several citations over the course of the year and will begin working with the city prosecutor's office to see potential next steps of enforcement to bring this property completely up to code.

The Board will continue to stay in contact with the City of Westminster Code Enforcement and the Management company will continue to take action where possible to improve the state of these properties. While we understand that it can be frustrating to see these in our neighborhood, you can rest assured that we are doing everything we can within the rule of the laws which govern our organization to improve the situation.

Board Members in Attendance - Matt Brozovich, Heather LaPuma, Tyler Urutty, Kathleen Dodaro, Valerie Westmark, Alan Meers, Kevin Murphy, Chuck Smith, and Sandy Owens.

Matt Brozovich made a motion to **approve** the minutes from the previous meeting. Tyler Urruty seconded. Passed Unanimously.

Officer's Reports

President - Matt welcomed our newest board member, Sandy Owens. Provided updates on two houses in the neighborhood; 10121 Yates Ct. and 4688 Hyland Greens Pl.

Secretary - Heather informed board that all insurance for Board and Directors has been updated. Treasurer - Tyler provided update on past month's financials.

Committee Reports

ACC Update - Approvals have quieted down now that we are entering winter.

Greenbelts - Kathleen provided update for the work on the tributary channel which should be trenched out in November. Kathleen is also in contact with the Highline Canal regarding clean up for the canal behind the neighborhood.

Valerie is working with the new landscaping contractor to hook up new rain sensors which should provide savings next year in our water consumption for the greenbelts. Also working to have tree removal done this winter and further review of the ash trees in the neighborhood.

Activities - Activities calendar for 2020 has been set and board members have selected the events that they will help run.

Pools - Matt made a motion to **approve** \$5000 to complete the installation of a surveillance camera at the big pool. Tyler seconded. Passed Unanimously.

Alan made a motion to **approve** \$20,500 for APM to install a double boiler heater at the Big Pool. Chuck Smith seconded. Passed Unanimously.

Other Business -

Alan made a **motion** for board officers to maintain their current positions. Kevin Murphy seconded. Passed Unanimously. Matt Brozovich - President, Pam Moores - Vice President, Heather LaPuma -Secretary, Tyler Urruty - Treasurer.

Covenant Updates - Chuck Smith will review and prepare a working version of the updated covenant document before the February 2020 meeting at which point the board will review the covenants. Perimeter Fence - Lewis Moses is working on 3 bids for the management of the fence replacement. Background checks for board members - Background checks can be used to limit who can serve as an office for the board.

January 18th was set as our informal 2020 Kick-Off. The next Board Meeting will be held on January 21, 2020.
